### Examples of Individual Holdings

*Digital Asset Exchanges* — Example: Coinbase Global, Inc: Offers financial accounts in the digital asset economy for retail users among other institutional and technological uses.

*Financial Services* — Example 1: PayPal Holdings, Inc: Operates a technology platform that enables digital payments on behalf of merchants and consumers worldwide. Users can hold digital assets within their accounts on the platform.

Example 2: Block, Inc (Square): Creates tools that enable sellers to accept card payments and provide reporting and analytics, and next-day settlement.

*Software* - Example: Shopify, Inc: Enables merchants to display, manage, market, and sell its products through various sales channels, including web/mobile storefronts and physical retail locations.

*Semiconductors* — Example 1: NVIDIA Corp: Operates as a visual computing company worldwide. Offers GeForce GPUs used in PC gaming, digital asset mining, and artificial intelligence.

Example 2: Advanced Micro Devices: Operates in four segments: Data Center, Client, Gaming, and Embedded Services. The company offers x86 microprocessors and GPUs.

*Next Gen Resource Miners* — Example: Riot Platforms, Inc: Operates through digital asset mining, data center hosting, and engineering segments.
