Digital Asset Exchanges — Example: Coinbase Global, Inc: Offers financial accounts in the digital asset economy for retail users along with other institutional and technological uses.

Financial Services — Example 1: PayPal Holdings, Inc: Operates a technology platform that enables digital payments on behalf of merchants and consumers worldwide. Users can hold digital assets within their accounts on the platform.

Example 2: <u>Block, Inc (Square)</u>: Creates tools that enable sellers to accept card payments, provide reporting and analytics, plus next-day settlement.

Software - Example: Shopify, Inc: Enables merchants to display, manage, market, and sell its products through various sales channels, including web/mobile storefronts and physical retail locations.

Semiconductors — Example 1: NVIDIA Corp: Operates as a visual computing company worldwide. Offers GeForce GPUs used in PC gaming, digital asset mining, and artificial intelligence.
