Index Definitions:

Bloomberg 1-3 year Government/Credit Index measures the performance of investment grade, US dollar-denominated, fixed-rate, taxable corporate and government-related debt with 1 to 2.9999 years to maturity.

Bloomberg Aggregate Bond Index is a market capitalization-weighted index designed to measure performance of the investment-grade domestic bond market, including Treasury securities, Government agency bonds, Mortgage-backed bonds, Corporate bonds, and a few foreign bonds traded in U.S.

Consumer Price Index All Urban Consumers Seasonally Adjusted (CPI) is a measure of the average change in prices over time of goods and services, including: food, clothing, shelter, and fuels, transportation fares, charges for doctors' and dentists' services, drugs, and other goods and services that people buy for day-to-day living. Seasonally adjusted CPI eliminates the effect of changes that normally occur at the same time and in about the same magnitude every year. June 2024 CPI was not available at the time this report was compiled, so June 2024 CPI was estimated using May 2024 CPI.

HFRX Global Hedge Fund Index is a representative index of the overall composition of the hedge fund universe comprised of all eligible hedge fund strategies; including but not limited to convertible arbitrage, distressed securities, equity hedge, equity market neutral, event driven, macro, merger arbitrage, and relative value arbitrage. The strategies are asset weighted based on the distribution of assets in the hedge fund industry.

S&P 500 Index (Total Return) is an unmanaged, capitalization-weighted index of 500 large-cap common stocks actively traded in the United States. The total return index measures both price and dividend performance of the underlying equities in the index.

MSCI All Country World Index (ACWI) is a market capitalization weighted index designed to provide a broad measure of equity-market performance throughout the world. It is maintained by Morgan Stanley Capital International, and is comprised of stocks from both developed and emerging markets.

FTSE World Government Bond Index measures the performance of fixed-rate, local currency, investment grade sovereign bonds. It currently comprises sovereign debt from over 20 countries.

60-40 Stock-Bond Index = 60% S&P 500 TR + 40% Bloomberg Aggregate Bond Index.

25-75 Stock-Bond Blend = (40% S&P 500 + 60% Bloomberg Agg. Bond Index from inception through 3/31/2013) + (25% Bloomberg Agg. Bd Index + 75% S&P 500 TR from 3/31/2013-current).

75-25 Stock Bond Blend = 75% MSCI ACWI + 25% FTSE World Government Bond Index
