

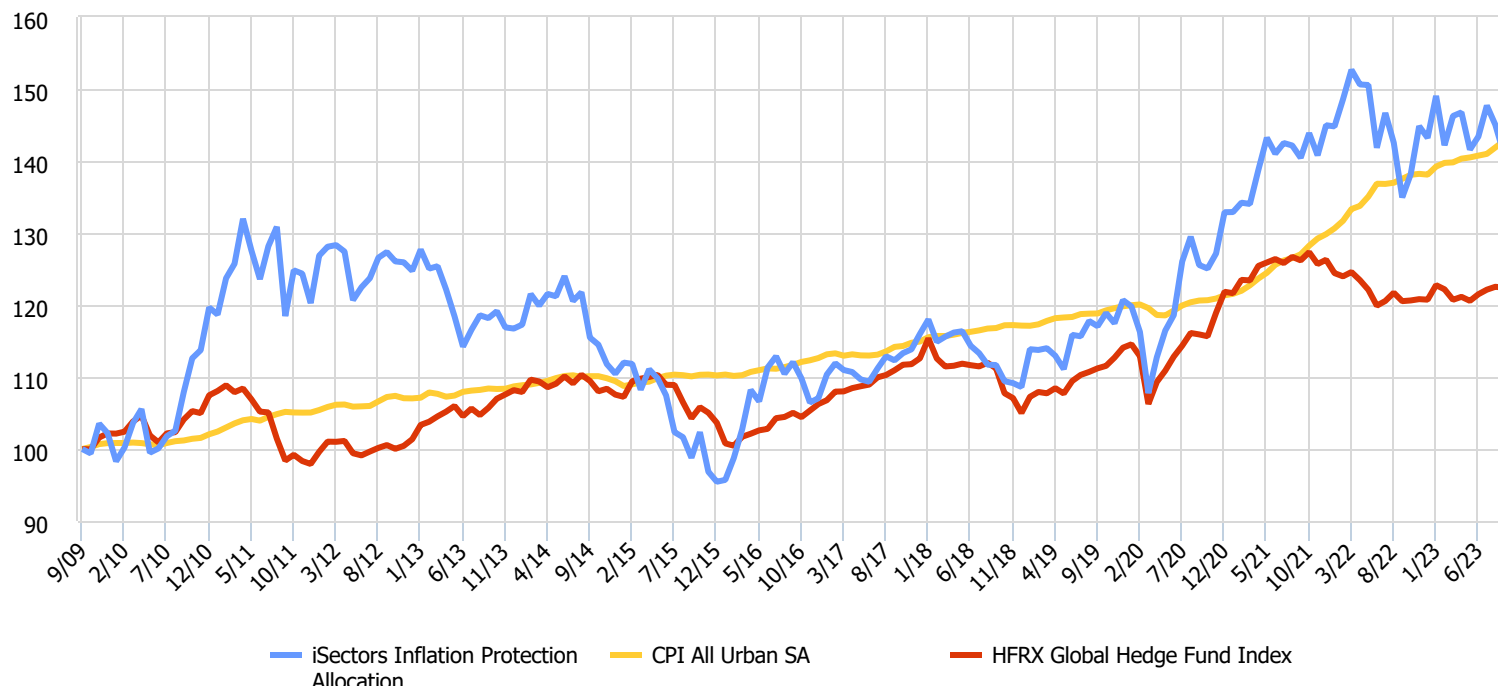
# iSectors® Inflation Protection Allocation
